Background:

One of the planned agriculture activities of Mercy Corps is to support vegetables farmers through provide household kitchen garden drip irrigation kits. The system distributes water through a network of valves, pipes, tubing, and emitters in a conservative way. Mercy Corps will provide 700 Kitchen Gardens kits to 400 farmers in Hasakeh governorate and 300 farmers in Raqqa governorate.

Supplier responsibilities:

- To provide 700 kits to Mercy Corps according to the requested specifications with technical acceptance of Mercy Corps team as follows:
 - ➤ Distribute 100 kits in Maabda rural.
 - Distribute 100 kits in Jawadiyah rural.
 - Distribute 200 kits in Hasakeh sub-district rural.
 - ➤ Distribute 150 kits in Ragga sub-district rural.
 - > Distribute 150 kits in Thaoura sub-district rural.
- To secure for the required permissions from the related authorities for kits transportations in the field.
- The Supplier will maintain title and will bear all risk of loss of the drip irrigation kits up to the point the drip irrigation kits are delivered to and accepted by Mercy Corps. Title and risk of loss of drip irrigation kits shall transfer to Mercy Corps upon delivery and after final acceptance.
- The Supplier will provide to Mercy Corps (Livelihood kitchen Gardens-Households Drip Irrigation kits) as specified in Bill of Quntity and Mercy Corps will make payment in consideration of such Goods in accordance with the terms of the Contract.
- The Drip irrigation kits must precisely adhere to the specifications. Additionally, the Supplier warrants that the drip irrigation will meet all of the quality specifications stated in Bill of Quantity.
- The Supplier agrees that the Specifications for drip irrigation kits, including the packaging will meet all requirements.
- The supplier will deliver the drip irrigation kits by loading them on supplier's trucks or supplier's designee trucks at the supplier's designated warehouse. The drip irrigation kits will not be deemed delivered until received to Mercy Corps' sites. Supplier shall ensure adequate equipment and labor to timely load and unload the drip irrigation kits to Mercy Corps' sites.

All costs incurred by the supplier or related to the drip irrigation kits, including, but not limited to, costs related to the transportation, loading or storage of the drip irrigation kits prior to delivery shall be exclusively borne by the Supplier.

- Supplier will make the drip irrigation kits available for inspection at its warehouse prior to delivery and will facilitate such inspection should Mercy Corps decide to proceed with such inspection.

- Items packaging:

The items included in the BoQ that need to be packaged are the following:

- ➤ Item 1 to 21 and the item from 27 to 29 to be packed in woven polyethylene bags for each kit.
- ➤ The other items (22 to 26) to be packed in safe method.

Timeframe / Schedule:

- Mercy Corps has ordered 700 kits of Drip Irrigation to be delivered within (30) days, with the final delivery.
