# **Call for Expressions of Interest (EOI)**

## 1. Background

Mercy Corps is a non-religious, non-profit and non-governmental international humanitarian organization. Present in more than 40 countries, Mercy Corps partners with communities facing crises and challenges to implement innovative and sustainable solutions that foster resilience and build stronger societies from within.

Mercy Corps Senegal launched its activities in 2022, following a merger with Energy for Impact, which had been operating in the country since 2012. The organization works to increase communities' access to sustainable and renewable energy in eight regions of Senegal.

As part of the MCA-Senegal II Program, funded by the Millennium Challenge Corporation (MCC), Mercy Corps is implementing the Productive Use of Electricity Facilitation Activity. This initiative aims to transform electricity access into tangible economic opportunities in the regions of Fatick, Kaolack, Kolda, Sédhiou, and Tambacounda, by supporting the adoption of modern equipment to boost productivity, strengthen local value chains, and improve the living conditions of rural populations.

Following several consultations with the donor, it was decided to relaunch this Call for Expressions of Interest (EOI) to expand the list of potential suppliers and enhance the competitiveness of the selection process. The initial EOI was open from October 1 to October 15, 2025, and the current EOI is relaunched for the period from November 13 to November 20, 2025.

Suppliers who have already submitted an Expression of Interest Form during the previous EOI period (October 1–15, 2025) are not required to resubmit a new form.

## 2. Purpose of the EOI

The purpose of this EOI is to identify **qualified suppliers** capable of supplying and installing productive-use electrical equipment in the following categories:

- Lot 1: Cereal mills, peanut paste mills, millet shellers, rice shellers, groundnut shellers, cashew nut shellers, electric mixers for soap making, oil presses, roasters, bio-charcoal equipment.
- Lot 2: Refrigerators, milk tanks, heat sealers, freezers, pasteurizers, food blenders, electric cookers, bakery equipment, seafood dryers.
- Lot 3: Irrigation pumps;
- Lot 4: Equipment for woodworking workshops, metalworking workshops, tailoring workshops, and vulcanization workshop.

#### 3. Areas of Intervention

Interested suppliers must be able to operate in the following regionsin Senegal: Fatick, Kaolack, Kolda, Sédhiou, and Tambacounda.

# 4. Eligibility Criteria

Applicants must:

- Be legally established and compliant with fiscal and social obligations;
- Demonstrate proven experience in the supply of similar equipment;
- Have sufficient technical and logistical capacity to operate in the targeted regions.

# Applications from women-led businesses or women's groups are strongly encouraged.
